KINDERGARTEN REGISTRATION Fall 2010

If your child is going to be five (5) years old on or before December 2, 2010, he/she is eligible to attend kindergarten for the 2010/2011 school year. Please follow the guidelines below.

WHAT TO BRING - Parents should bring the following items to register their child.

1. Proof of birth date (birth certificate, statement by local registrar or county recorder certifying date of birth, baptismal record duly attested, or passport)
2. The most current immunization records that are signed or stamped by a doctor.

PROOF OF ADDRESS - Please provide one document from each of the three categories listed below.

1. Show a current picture ID of parent/guardian: Driver's license, CA issued ID, or passport, etc., and
2. A current mortgage statement (escrow papers that show close of sale no later than seven (7) days after the student's first day of school), grant deed, property tax bill, lease/rental agreement including property address, names of occupants, signatures of both parties with 2 months of canceled checks; or bank transfer records with the current school year
3. A current PG&E, garbage, cable, or water bill with name and address listed (with 45 days for NEW home purchases/rentals)

(If you are unable to provide the required proof of residency listed above, please seek assistance from the school office)

Registration at the school of residence does not guarantee enrollment at that school (BP 5111).

OPEN ENROLLMENT

Parents preferring a kindergarten placement at a school other than the one assigned based on home address must first register at their home school. After registering, complete the Intradistrict Transfer form and return it to the school office. Parents will be notified about transfer requests by the end of the school year.

Note: The Livermore Valley Joint Unified School District will not be accepting Intradistrict Transfer applications to the following four elementary schools for the 2010-2011 school year: Arroyo Seco, Croce, Smith, and Sunset. Sibling requests will be considered, but there is no certainty of available space.
